The purpose of this policy is to provide management expectations for environmental protection and improvement that align with ISO 14001 standard requirements. The scope of this policy includes all Central Plateau Cleanup Company (CPCCo) operations under Central Plateau Cleanup Contract – 89303320DEM000030 at Hanford.

**2.0 POLICY**

It is CPCCo policy to be responsible stewards of the environment while meeting its mission of cleaning up the Hanford Central Plateau and protecting the Columbia River. Sustainable environmental stewardship practices shall be incorporated as a core value in all our operations. CPCCo is committed to achieving environmental excellence through the systematic integration of environmental protection, as well as worker health and safety protection and quality principles, throughout our operations. To this end, CPCCo will establish, document, implement, maintain, and continually improve an environmental management system (EMS) that will be an integral component of the CPCCo Integrated Safety Management System.

In support of this policy, CPCCo shall:

- Comply with applicable environmental obligations.
- Implement environmental sustainability practices, including resource conservation, waste minimization, pollution prevention, chemical management, and green purchasing.
- Assess our activities and promptly report and seek to correct environmental incidents and deficiencies.
- Determine on an annual basis the aspects of our operations that impact the environment and establish objectives for environmental improvement, and implement planned actions to achieve them.
- Provide CPCCo workers and stakeholders with timely, accurate, and meaningful information related to our environmental performance.
- Conduct on an annual basis, a review of our environmental performance, identifying programmatic strengths, weaknesses and areas needing improvement, and providing results of this review to CPCCo top management.
- Work, with input from CPCCo workers, and external stakeholders when practical or required, to continually improve our EMS and our environmental performance.

This environmental policy shall be communicated internally to all CPCCo workers, made available externally to interested parties, and maintained as documented information. All CPCCo workers are expected to be aware of and adhere to this policy within their areas of responsibility.
