DESCRIPTION OF AMENDMENT

Request for Proposal 357905 “Outer Area End States Construction Facility Maintenance Services” is hereby amended to replace “Attachment 1 – SOW”, Attachment 1.1 – Appendix A” and “Attachment 1.2 – Task Appendix B” with their version 1 revisions. These revisions address the need for two additional buildings to be added to the scope as well two buildings to be added in as possible future scope under this contract. The version 1 documents supersede all previous revisions.
